MANAGEMENT HAS DEFERRED THE INCOME RECEIVED FOR THESE EVENTS UNTIL 2021. IN RESPONSE TO COVID-19, THE ORGANIZATION ELECTED TO CREATE STRICT GUIDELINES FOR COMMUNITY SAFETY DURING MEAL PACKING EVENTS. THIS INCLUDED SOCIAL DISTANCING, FACE MASKS, GLOVES, FACE SHIELDS, AND SUFFICIENT AIR FLOW. THESE GUIDELINES GREATLY REDUCED THE NUMBER OF VOLUNTEERS THAT COULD PARTICIPATE IN MEAL PACKING EVENTS. THEREFORE, THIS REDUCED THE REVENUE RECEIVED IN 2020.
